6. CAPITAL NOTE AND LEVY

DSHK is a not-for-profit, child-centered private primary school. DSHK does not receive any operating or capital grants from the Hong Kong Government. A Capital Contribution Scheme has been established by Dalton Foundation Limited by the issuance of the Corporate Capital Note, Individual Capital Note and Annual Non-Refundable Capital Levy to help finance the construction and maintenance of the School, the acquisition of new facilities and equipment, and additions, enhancement and replacement of these facilities thereafter. For applicants who is not capital note nominees, there is an annual payment of the Capital Levy. The Capital Levy is non-interest bearing, non-refundable and non-transferable.
